# IT BEGINS WITH YOUR PARTICIPATION

The taxpayer may select the Catholic School(s) in the Diocese of Greensburg to which they would like to make a contribution, in exchange for PA State Tax Credits.

Minimum contribution

\$1,000

- Individuals must earn enough in state taxable income to participate.
- Business or individual taxpayers receive credits against Pennsylvania State Taxes

for **90%** of that amount each year for a two-year commitment.

· The school will receive

Up to 100%

of the donor's contribution for tuition assistance in the next school year.

#### **EXAMPLE:**

The Smith family contributed \$10,000 through the EITC program, as part of a two year commitment, and receives \$9,000 in state tax credits for that fiscal year. The remaining \$1,000 may be claimed as a charitable contribution. Consult your Tax Professional for professional advice.

### HOW ARE TAXPAYER CONTRIBUTIONS USED?


The Diocese of Greensburg utilizes EITC for tuition assistance for students in grades K-12. Receiving families must meet financial requirements.


### HOW IS FINANCIAL NEED DETERMINED?

Each of the Catholic Schools in the Diocese of Greensburg uses a **third party tuition management** system to evaluate and determine the financial needs of individual families.

## CAN A TAXPAYER DESIGNATE A SPECIFIC SCHOOL TO RECEIVE ITS CONTRIBUTION?

Taxpayers may designate their contribution to the school of their choice or to the Diocese of Greensburg who will then allocate their contribution between two or more schools within the Catholic Schools in the Diocese of Greensburg.
